**Opening discussion:** How do we help, support, include, and engage seniors without being invasive?

**Speaker:** Jocelyn Sharp-Henning from the Nashua Senior Center, 70 Temple St., Nashua.

- Target constituency: Age 50 and over.
- Organization is a stand-alone 501c-3.
- Facility: 23,000 square feet. Rented from the city for \$1 per year, and the rest of the budget is from fundraising, rentals, membership fees. Run by a small staff and over 150 volunteers.
- Half of the building is apartments run by Southern NH Services.
- Programs: Exercise, music, quilting, knitting, painting, dancing. Classes are ongoing and one-time. Trips. Special events (socials, dinners, movies). Gaming groups (cards, billiards, pickle-ball). Biking and walking groups. Seminars (estate planning, driving, etc.). Annual talent show (fundraiser). Thrift store. ServiceLink referral service is located in the facility.
- Membership: \$40/yr for one person; \$60 per 2-person household. Small fee for activities to pay instructors.
- Partnerships: Rivier University, Home Health Hospice, St. Joseph's Community Services (meals), St Joseph Hospital visiting nurse, Veterans Administration, Southern NH Services Bone Builders.
- Goal: To keep people as healthy, active, mentally well and social as possible.
- Community issues during Covid: battling the isolation created by the pandemic through phone calls, zooms. The more we can connect, the better and healthier we can be.
- Recommended ways to try to connect with isolated seniors: transportation to medical appointments, phone/zoom folks and ask what they need.
